Entry Agreement

Assumption of Risk, Waiver and Indemnification-

This document waives important legal rights. Read it carefully before signing.

I AGREE in consideration for my participation in this Competition to the following:

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm"). Under the state Equine Activity Liability Act, each participant who engages in an equine activity expressly assumes the risks of engaging in and legal responsibility for injury, loss, or damage to person or property resulting from the risk of equine activities.

I AGREE to release Cinnamon Ridge Farm, it's owners, employees and agents from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Cinnamon Ridge Farm, it's owners, employees and agents .

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of Cinnamon Ridge Farm, it's owners, employees and agents or the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) Cinnamon Ridge Farm, it's owners, employees and agents and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition.

I have read the Show Rules about protective equipment and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the show strongly encourages that I do so while WARNING that no protective equipment can guard against all injuries.

I understand that under the state Equine Activity Liability Act, each participant who engages in an equine activity expressly assumes the risks of engaging in and legal responsibility for injury, loss, or damage to person or property resulting from the risk of equine activities.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf.

I AGREE that Cinnamon Ridge Farm, it's owners, employees and agents as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers, affiliated organizations and competition management.

I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

I AGREE that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to Cinnamon Ridge Farm, it's owners, employees and agents on a Cinnamon Ridge Farm accident/injury report form.
